5. Performance & Consultation Clause

The exclusivity outlined in Section 3 is binding provided there is no interruption in the service or supply chain. In the event of supply issues, Ubuntu Glamping agrees to undergo a formal consultation process with the Supplier to resolve the matter before seeking alternative solutions.
